"Europe for Citizens" has gone from us

- It was an EU-Programme from 2014 – 2020 with a budget of 184 Mio. €
- Funding schemes for Town Twinning ("Meetings of Citizens") with up to 25.000 € or up to 150.000 € ("Networking Projects")
- Funding schemes for applicants such as NGOs, remembrance sites, educational and cultural organisations with a focus on history of the 21st century ("Remembrance Projects" up to 100.000 €) and "Civil Society Projects" (up to 150.000 €)
- Rather simple application based on lump-sums
- Eligible in 27 EU countries plus Albania, Serbia, Montenegro, Kosovo, Bosnia-Herzegovina, North-Macedonia

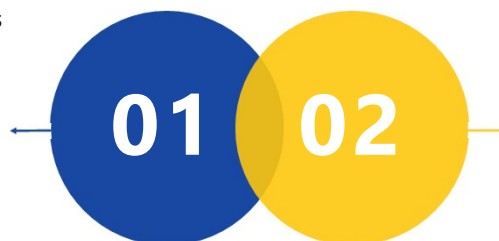

General Objectives of CERV

To protect and promote the rights and values enshrined in the Treaties, the Charter of Fundamental Rights of the European Union and in the applicable international human rights conventions. The programme does this in particular by supporting civil society organisations and other stakeholders active at local, regional, national and transnational level

- Protecting and promoting children's rights, the rights of persons with disabilities and civil rights




Citizens' Engagement and Participation

Specific objectives of this strand II/II

- Supporting projects aimed at commemorating defining moments in modern European history, such as authoritarian and totalitarian regimes, and projects aimed at raising awareness among European citizens of their common history, culture, cultural heritage and values
- enhancing the understanding of the Union, of its origins, purpose, diversity and achievements and of the importance of mutual understanding and tolerance
- Promoting citizens' and representative associations' participation in and contribution to the democratic and civic life of the Union by enabling them to make known and publicly exchange their views in all areas of Union action
- Promoting exchanges between citizens of different countries, in particular through town-twinning and networks of towns



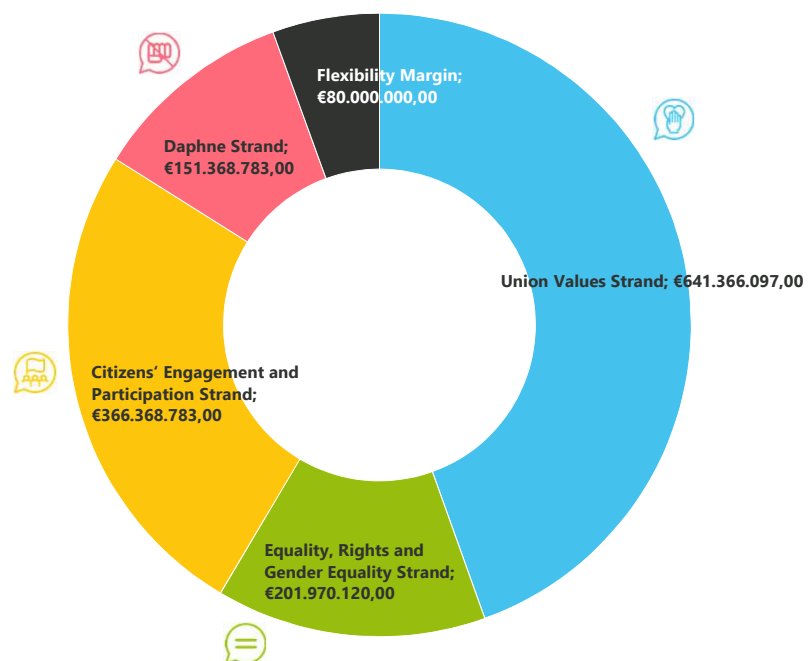


- Workshops, seminars, conferences

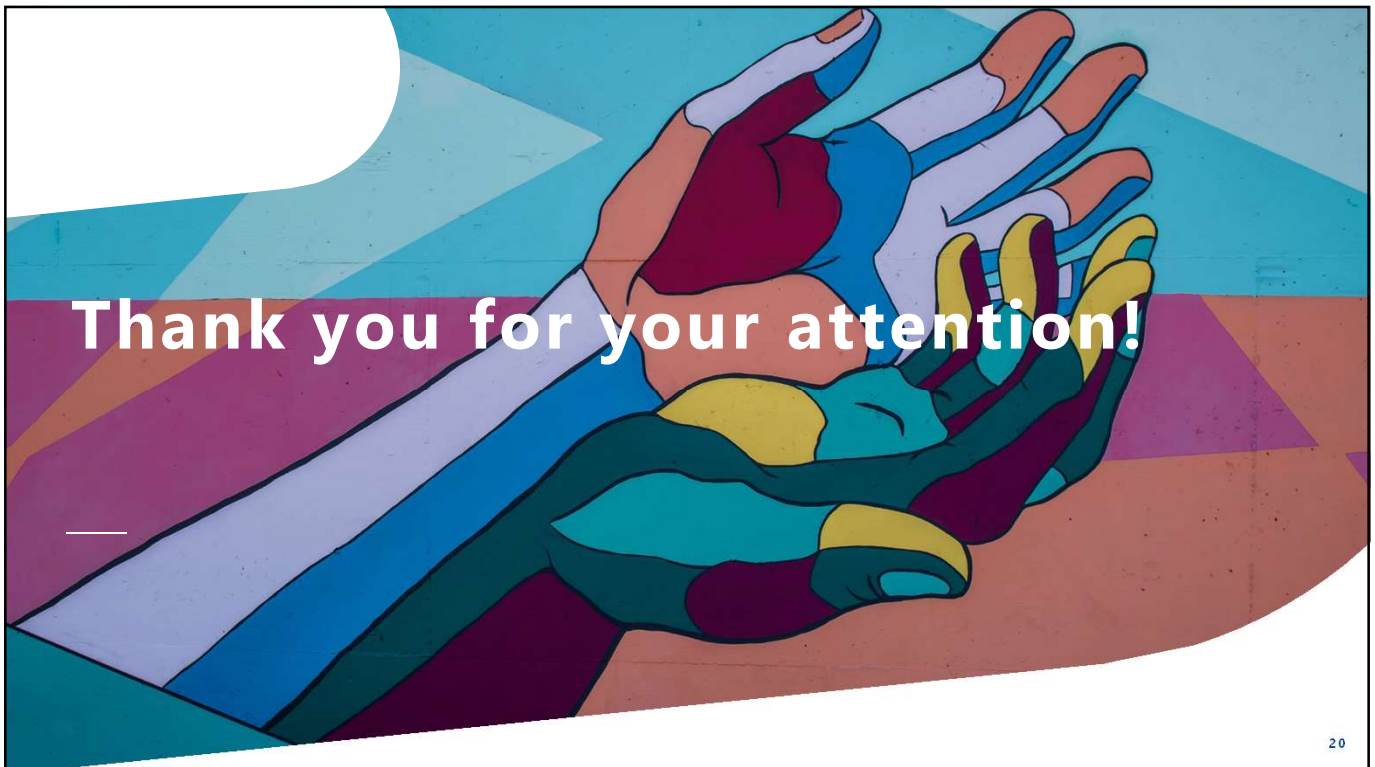
